GREENPLAST 2025 GENERAL REGULATIONS

This version is a translation compiled solely to assist the comprehension of the original version of the General Reguations in Italian. Only the Italian text is legally binding with regard to relations between exhibitors at **GREENPLAST 2025** and PROMAPLAST srl.

1 Organization

GREENPLAST 2025 - EXHIBITION AND CONFERENCE FOR A MORE SUSTAINABLE PLASTICS AND RUBBER INDUSTRY at its second edition, is organized by PROMAPLAST srl in cooperation with FIERA MILANO spa. **GREENPLAST 2025** Secretariat is at the premises of PROMAPLAST srl: Centro Direzionale Milanofiori, Palazzo F/3, 20057 Assago (MI) - tel. (+39) 02 82283743 info@greenplast.org - www.greenplast.org.

In the period immediately preceding **GREENPLAST 2025**, the Secretariat operates from the FIERA MILANO spa Fairgrounds: the location and phone and fax numbers are notified to the exhibitors fifteen days before the start of the show.

2 Date, Venue and opening hours

GREENPLAST 2025 is held from Tuesday 27 May to Friday 30 May 2025 inclusive, at the Fieramilano Fairgrounds, Rho, with entrance from South, East and West gates. **GREENPLAST 2025** is open to visitors and the ticketpaying general public, from 9.30 a.m. to 6 p.m., without any intermediate breaks. Exhibitors are allowed access to the Fairgrounds at the following times: from 8 a.m. to 7 p.m. on Tuesday 27 May 2025; from 8.30 a.m. to 7 p.m. from Wednesday 28 May to Friday 30 May 2025. Exhibitors have to attend their assigned stand during the opening hours to the public. Children under the age of 18 are admitted only if accompanied by adults, with the mandatory acceptance of responsibility on the part of the accompanying adult.

The Organiser reserves the unquestionable right to change the timetable and, if necessary, the date of the Exhibition, as well as the venue of the Exhibition, for motivated technical and organisational reasons, with notice to the operators in the sectors concerned. In the event of a change in the dates, times and/or venue of the Exhibition, the exhibitors shall not be entitled to any compensation and they undertake, from now on, to participate in the Exhibition as modified in terms of dates, times and/or venue, under the same conditions as those set out in these General Regulations.

3 Admitted products

It is possible to exhibit at **GREENPLAST 2025** the following products, all relating to the plastics and rubber industry and their recovery, recycling and reuse, including for environmental sustainability and energy efficiency purposes: machinery and plant auxiliary equipment moulds, dies and accessories raw materials, regenerated materials and composites semi-finished and endproducts specialist press
services and related sectors, all regarding the plastics and rubber industry. Products to be exhibited cannot be brought into the Fairgrounds during opening hours to the public. Exhibitors are not allowed to sell products shown directly to visitors or to exact related payment. Sales can only be made in the form of orders, with delivery deferred to a later date. No products on show can be removed from the stand before the show has closed to the public. For all products, machines and equipment, and in particular those exhibited in operation, article 26 of these General Regulations apply, along with all further regulations described in the FIERA MILANO spa Technical Regulations (see articles 20 and 25 of the present General Regulations).

4 Exhibitors

Companies can exhibit at **GREENPLAST 2025** by presenting the duly compiled application form (see article 10). Likewise, the companies publishing specialist press and periodicals, official organizations, associations, institutes etc. can also take part, as long as their activity is performed to promote, support or implement activities connected to or related to the Exhibition's trade sectors and characteristics. In addition, craft-sized companies working in related industry can also take part in **GREENPLAST 2025**. The regulations applied to exhibitors as described in these General Regulations are also applied to the companies described in articles 5, 6 and 7, where applicable and unless of specific distinctions.

5 Co-exhibitors

Co-exhibitors can also apply to exhibit without booking their own stand but being hosted at an exhibitor's stand, in accordance with their manufacturing or industrial agreements. The co-exhibitor has to fill out the obligatory online forms made available by PROMAPLAST srl into a reserved internet area, previous consent by the hosting exhibitor. The admission fee for co-exhibitors is 1,200 euro + VAT, which entitles said co-exhibitors to: inclusion in the alphabetical list and in the list by product category of the official printed and on-line catalogue (including mobile version) for GREENPLAST 2025, one copy of the printed version, as well as an entrance card for the entire show period (see article 18). A maximum of two co-exhibitors are allowed at the stand of one exhibitor, except in the case of circumstances described by the exhibitor which are taken into consideration by PROMAPLAST srl, whose decision regarding approval or rejection is incontrovertible. Co-exhibitors cannot represent other companies. Co-exhibitors who have not enrolled officially for the Exhibition are not admitted. PROMAPLAST srl and FIERA MILANO spa reserve the right to verify the brands and/or products shown and, in the case that brands and/or products belonging to co-exhibitors who have not enrolled in the Exhibition are found, to remove said brands and/or products, charging the related expenses to the exhibitor renting the stand.

6 Represented companies

If some manufacturing companies wish to exhibit at



GREENPLAST 2025 by means of their representative's stand, the representative is required to assume the written responsibility on behalf of and towards the represented company together with the application form. The representative exhibitor is required to specify, on the obligatory online forms made available by PROMAPLAST srl into a reserved internet area, the names and respective information of all the companies represented and whose brands and/or products are presented on his stand. For each represented company, the exhibitor is required to pay an admission fee of 250 euro + VAT, which entitles the name of the represented company to be included in the official printed and on-line catalogue, including mobile version (under the name of the representative exhibitor in the alphabetical list, and in the specific list of represented companies), and likewise the inclusion of products exhibited in the list by product category (under the name of the representative exhibitor). The fee also entitles each represented company to one entrance card for the period of the show, which is sent to the representative exhibitor (see article 18). In case of withdrawal from one or more represented companies, the respective admission fees already settled by the exhibitor cannot be refunded, neither they can be compensated with substituting applications. PROMAPLAST srl and FIERA MILANO spa reserve the

right to verify the brands and/or products shown and, in the case that brands and/or products belonging to represented companies who have not enrolled in the Exhibition are found, to remove said brands and/or products, charging the related expenses to the representative exhibitor.

7 Agents in Italy of direct foreign exhibitors

Foreign companies who book their own stand directly can specify their agent in Italy, if they have one, on the obligatory online forms made available by PROMAPLAST srl into a reserved internet area, assuming all responsibility on behalf of and towards the agent, who is thus included in the alphabetical list of the official GREENPLAST 2025 catalogue at no extra cost, in addition to the company details of the foreign exhibitors themselves. An agent is not allowed to display brands and/or products by other com- panies, for whom he is also an agent, on the stand rented by the foreign company whom he represents. PROMAPLAST srl reserves the right to verify the brands and/or products shown, and in the case that brands and/or products by other companies not officially enrolled at GREENPLAST 2025 are found, to remove said brands and/or products, charging the related expenses to the exhibitor renting the stand. If the agent intends to present, at GREENPLAST 2025, brands and/or products by other companies that he represents, the agent is required to book a stand and to communicate the names of the other companies represented, in the devoted online forms.

8 Participation fee

The participation fee for **GREENPLAST 2025** is officially determined by PROMAPLAST srl. Taxes and duty that are applicable in accordance with current legislation and with

any new legislation that may be introduced will be added as appropriate, and are payable by the exhibitor. If any tax or duty should no longer be payable in the respective financial year as a result of changes in legislation, PROMAPLAST srl will return the corresponding sums that have already been paid. Minimum stand size is set at 16 square meters, except for special circumstances for which the decision on the part of PROMAPLAST srl shall be final and incontrovertible. The following participation fee is applied at GREENPLAST 2025 for raw space rental:

185 euro/sqm + VAT

The following surcharges are applied:

- \Box 1,000 euro + VAT, for stands with two open sides
- □ 1,500 euro + VAT, for stands with three open sides
- \Box 2,000 euro + VAT, for stands with four open sides.

Exhibitors can apply for a stand with two, three or four open sides, preferably in the case that they book an area of at least 24 sqm, 48 sqm, or 160 sqm respectively. PROMAPLAST srl is under no obligation to guarantee the supply of space with said characteristics.

In the case that, as a result of technical and organizational constraints, an exhibitor is assigned a stand with two or more open sides without these having been requested, and/or with a stand size lower than the minimum specified above, the exhibitor is in any case required to pay the respective surcharge, once the assigned stand is accepted. The participation fee at GREENPLAST 2025 includes the rental charge for the space and the following services:

- inclusion of the names of the exhibitor and co-exhibitor in the Alphabetical List and in the List by product category in the Official printed Catalogue for GREENPLAST 2025, including mention of any companies represented by the exhibitor in the devoted spaces;
- inclusion of the names of exhibitor and co-exhibitor in the Alphabetical List and in the List by product category of the online GREENPLAST 2025 catalogue, including mobile version, within the FIERA MILANO spa Expo Plaza Internet portal, activated 2 months before the show, including mention of any companies represented by the exhibitor in the devoted spaces;
- one copy of the Official printed Catalogue for GREEN-PLAST 2025, available from Monday 26 May 2025;
- □ graphic files for general promotion, available for exhibitors who wish to use it.

Also included in the participation fee are the costs absorbed by PROMAPLAST srl for general promotional activities of **GREENPLAST 2025**, and the advertising, in Italy and abroad, performed by PROMAPLAST srl, including promotion on specialist on-line portals; and likewise, the complementary events organized by PROMAPLAST srl (conferences, meetings etc.) before and during the Exhibition, including arrangements made for prospective delegations of professional operators, official representations from Italy and abroad, and speakers and expert guests. Upon balance payment of the participation fee, each exhibitor has to pay the fee invoiced by PROMAPLAST srl for indis-



pensable services (see article 10 of the General Regulations).

9 Stands pre-fitted by FIERA MILANO spa

For exhibition spaces measuring **16**, **24**, **32**, **48** or **64** sqm, the exhibitor undertakes to order, at the appropriate time, the fixtures and fittings provided by FIERA MILANO spa at a cost of **80** euro/sqm + VAT, in addition to the cost of participation fee for raw space rental. These fixtures and fittings consist of basic equipment, as shown on the exhibition site; in due course, exhibitors may also order supplementary fixtures and fittings at their own expense. For exhibition spaces measuring more than **64** sqm, the exhibitor can fit out the assigned area independently, in compliance with the rules laid down in such cases, or alternatively contact FIERA MILANO spa for a quote for a customized solution.

10 Indispensable services supplied by FIERA MILANO spa

For some indispensable services supplied – on behalf of the Organizer - by FIERA MILANO spa and/or appointed third-party suppliers, it is invoiced by PROMAPLAST srl the fee of 20 euro/sqm + VAT, that the exhibitor is held to settle upon payment of balance invoice for the participation fee.

Above-mentioned indispensable services include:

- □ sign with the stand number, which is delivered before the end of the mantling period;
- technical assistance during mantling, the show itself, and dismantling;
- □ floor carpet in the Halls' gangways
- one car park inside the Fairgrounds for each exhibitor during entrance hours for exhibitors;
- wi-fi connection inside the Halls during show hours (200 Kbps);
- cleaning of the stand floor area (including emptying of any rubbish bins present), performed after 7 p.m. from Monday 26 to Tuesday 29 May 2025;
- approved fire-extinguisher (a 6-kg powder extinguisher; 1 extinguisher for each 50 sqm area of stand or fraction thereof);
- activation of first CEE socket (32 A/400 V 3 P+N+E) till 10kW of installed power;
- □ Advertising Tax. Without prejudice to the participation regulations, the exhibitor is required to pay the Municipality of Rho the fee required pursuant to Law 27/12/2019, n. 160. As a result of agreements made with the Municipality to the benefit of the exhibition sectors involved, this tax is established as a lump sum according to the total area taken up by the Exhibition, so that exhibitors are not required to perform costly and timeconsuming procedures. FIERA MILANO spa in fact pays the respective tax directly to the Municipality of Rho;
- copyright payable in function of audiovisual installations in the stand, which are subject to taxation. This does not include the rights payable in the case of live performances (with singer and/or musical instruments), for

which the exhibitor should pay the duty owed directly to SIAE offices in the city. If the exhibitor wishes to distribute audio, video or multimedia products containing intellectual property, or excerpts from works of intellectual property, protected as regards author's rights in accordance with Law n° 633, 22.4.1941, the rights payable should be paid in advance, and the procedures regarding the application of the respective official label to the support must be performed in accordance with article 181bis of the same law. The unauthorized use of intellectual property and the absence of the SIAE sticker on said supports are subject to criminal penalties, in accordance with articles 171 foll. of law 633/41;

duty owed in accordance with articles 72 and 73bis, law 633/1941, to the performing artists and the phonographic producers owning the rights for recordings, and the Società Consortile Fonografici (SCF, Recording company consortium) which acts on their behalf.

This does not include the rights owed to performing artists and recording companies with respect to the provisions of article 73 of the above-stated law, for the broadcast of recorded music and music videos during fashion shows, and DJ sets with or without dance performance. Therefore, an exhibitor who wishes to organize this sort of event should contact SCF - Società Consortile Fonografici, Via Leone XIII, 14 – Milan, in order to complete the procedures specified for this legislation.

11 Application

The application form for GREENPLAST 2025 has to be presented exclusively using the obligatory online forms made available by PROMAPLAST srl into a reserved internet area, to be compiled in full by the exhibitor, then printed, stamped and signed where required and sent within 31.07.2024 to PROMAPLAST srl - Centro Direzionale Milanofiori - Palazzo F/3 - 20057 Assago (Milan). The forms must be accompanied by the admission fee - which partially covers the organizers' administrative costs - of 400 euro + VAT, and a deposit (down-payment of the participation fee) of 80 euro + VAT per square meter booked.* In case of VAT exemption in accordance with articles 8/8bis/9 of DPR 633/72 and further possible modifications, two declarations have to be enclosed, respectively addressed to PROMAPLAST srl and FIERA MILANO spa. PROMAPLAST srl accepts only application forms that are signed by the legal representative of the exhibiting company, compiled in compliance with the provisions of these General Regulations, and that are accompanied by the payment of the admission fee and downpayment of the participation fee. Exhibitors are not allowed to add their own conditions, and/or variations in the conditions of participation, to the application forms. The application form must be considered as an irrevocable proposal made by the prospective GREENPLAST 2025 exhibitor to PROMAPLAST srl and PROMAPLAST srl has the right to accept or refuse the proposal. If PROMAPLAST srl does not accept the application, the sum paid by the prospective exhibitor is promptly returned, without the application of any interest. In compliance with art.1, co. 909, Law 27 December 2017 (compulsory issuance of electronic invoice between private companies from 01/01/2019), the exhibitor with invoicing address in Italy has to submit to PROMAPLAST srl its own Certified Electronic Mail address (PEC) and/or its own delivery code (seven figures), in the devoted fields provided by PROMAPLAST srl in the compulsory online application forms.

*From 1 January 2011, according to D.Lgs. n.18/2010 following UE Directive n.8/2008, foreign exhibitors subject to taxation are not subject anymore to VAT on the participation fee for **GREENPLAST 2025** (see article 8), neither on the shell scheme supplied by FIERA MILANO (see article 9), nor on the indispensable services invoiced by PROMAPLAST srl (see article 10). However, provisions mentioned in the same articles 8, 9 and 10 are valid regarding possible newly introduced or re-introduced taxation, following further law modifications. Moreover, exhibitors without a permanent address in Italy can recover Value Added Tax still due on the exhibition's invoices for additional services: for further information, see "VAT Refund" on www.greenplast.org, "exhibitors area".

12 Stand assignment

Stand assignment is determined by PROMAPLAST srl upon unquestionable judgment, primarily in accordance with the subdivision by the various product sectors at the show, in consideration of the characteristics of the products to be exhibited - as declared by the exhibitor in the mandatory online application forms in the website www.greenplast.org - and also considering the technical plant within the halls of the FIERA MILANO Fairgrounds, Rho, and the chronological order of submitted applications. The application of these product classification and technical criteria cannot be guaranteed for exhibitors who fail to send their application form in due time, and likewise for exhibitors who do not compile the mandatory form concerning exhibits and technical needs correctly. The assignment of stands to exhibitors presenting their application after 31.07.2024 is performed in accordance with the spaces that may still be left and that may be available in the GREENPLAST 2025 exhibition halls. PROMAPLAST srl announces stand assignment by means of the reserved area for exhibitors on the website www.greenplast.org. Exhibitors receive the personalized codes necessary to log in this area in accordance with the date on which they presented their application form (within 15.1.2025 for exhibitors who enrolled by 31.07.2024, or later in the case of later enrolment). The definite confirmation of the assigned stand is given by the official notice of stand allocation issued by PROMAPLAST srl and not by the confirmation of acceptance by the exhibitor. For technical and operational reasons, PROMAPLAST srl reserves the right to change the location of stands initially assigned, giving timely notice to the in-



terested exhibitor and always in compliance with the subdivision by product at **GREENPLAST 2025**. A change in stand position of this sort does not entitle exhibitors to withdraw their application, and neither does it entitle exhibitors to any reimbursement for damages of whatever nature. In all cases, exhibitors are not entitled to take legal action against PROMAPLAST srl for damages of whatever nature. Exhibitors are expressly prohibited from subletting the stand assigned, or a part thereof.

13 Withdrawal

If an exhibitor decides to withdraw his application at **GREENPLAST 2025**, PROMAPLAST srl acquires the right to retain the sums paid by the exhibitor for whatever reason, and to use the respective area as it wishes. If the exhibitor withdraws after having received the official notice of stand assignment, and in any case after 28.2.2025, the exhibitor is required to pay the entire participation fee. In any case, PROMAPLAST srl has all and every right to take legal action and to sue for damages the exhibitor who has withdrawn, if deemed applicable.

14 Reductions

For shell scheme areas until 64sqm no reduction is allowed.

For areas over 64sqm before the official notice of definitive stand assignment, and in any case not beyond 28.2.2025 in the case that the official notice has not yet been issued, if an exhibitor wishes to reduce the area that was booked on enrolment for **GREENPLAST 2025**, the deposit paid for the area relinquished by the exhibitor is retained by PROMAPLAST srl as reimbursement for organizational expenses. In any case, **requests for reductions of over 15% of the area booked are not accepted.**

15 Terms of payment

The balance of the participation fee must be paid by the exhibitors within 15 days of receipt of the debit note issued by FIERA MILANO spa, on behalf of PROMAPLAST srl, following the official notice of definitive stand assignment. In the case that such official notice is issued after 28.2.2025, the balance of the participation fee must be paid on receipt of the debit note. By submitting its regular application form, the exhibitor accepts that PROMAPLAST srl and FIERA MI-LANO spa have faculty to send invoices by e-mail to the account mentioned by the exhibitor in the application form itself (for Italian companies mandatorily by P.E.C., audited e-mail system, as per current law). It is allowed entrance to the Fairgrounds and the contractual services are supplied only to the exhibitors who settle balance payment in due time. Payments for the above-mentioned fees must be made to: FIERA MILANO SPA,

with bank expenses to be borne by the exhibitor. Payments made from outside Italy by Italian or foreign exhibitors must



be made in such a way so that any bank expenses be paid entirely by the exhibitor, who has to provide clear instructions for the bank transfer specifying that all charges made by the respective Italian and foreign banks must be paid by said exhibitor. On behalf of PROMAPLAST srl, the holder of the above current account is FIERA MILANO spa, whose registered office is in Piazzale Carlo Magno 1, 20149 Milan, Italy, VAT N. 13194800150.

Notice on financial flow track duties: PROMAPLAST srl, by supplying services foreseen in the present Regulations, ensures compliance of all mentioned duties, following article 3 of law 13.08.2010, n. 136 and further modifications, with regard to any exhibitor that is a public body or controlled by a public body or considered as "appointing contractor" according to said law, or the contractual relation can be cancelled with immediate effects. Said exhibitor has to fill the application form with the mandatory code CIG (identification number of the public tender) or whereas necessary with CUP (sole project code) concerning underpinning public investment.

16 Advertising in the Fairgrounds and on-line advertising With the exception of advertising promotion within the exhibitor's stand, other forms of advertising promotion can be performed by exhibitors in permitted forms within the Fairgrounds, as managed by FIERA MILANO spa in cooperation with PROMAPLAST srl, and said companies reserve exclusive rights to the management of advertising, even in the case that specialist agencies are also involved, following the guidelines of the portal described in article 19 of these Regulations. Exhibitors can also commission paid advertising insertions in the website www.greenplast.org, and likewise in the Expo Plaza portal run by FIERA MILANO spa in the section dedicated to GREENPLAST 2025, starting from 2 months before the exhibition, following the guidelines made available in due time within the above mentioned portal.

17 Official catalogue – standard information included, and supplementary information subject to payment

PROMAPLAST srl reserves exclusive rights for the publication of the official GREENPLAST 2025 catalogue, even on electronic support and/or further means according to later technical developments, and to the sale of this publication. The catalogue contains the alphabetical list and the list by product category, plans of the Exhibition, other useful information, and paid advertising (euro 500 + VAT/page), bookable by exhibitors using the optional online form, by 28.2.2025. This deadline also marks the deadline after which any further enrolments, or changes in company information and product category for already enrolled companies, are made exclusively online, except in the case that PROMAPLAST srl should decide - its decision in this regard being final and incontrovertible - to publish a supplement to the printed catalogue. Exhibitors and co-exhibitors provide and undersign the data for free inclusion in the alphabetical list and the list by product category, and likewise the orders for additional insertions subject to payment, by compiling the mandatory online forms made available by PROMAPLAST srl into a reserved internet area. Exhibitors and co-exhibitors are required to promptly inform PROMAPLAST srl of any variations that may have occurred for the data provided with said forms, including reference to companies represented by the exhibitor or a possible Italian agent for a foreign company that has booked a stand, whose data are filled in the devoted section of the online application form.

Exhibiting companies have sole responsibility for the consequences of failing to provide prompt notification of changes in information (see also article 34 regarding the exhibitor's bank details). Exhibitors and co-exhibitors can request free insertion of their company names in the list by product category in correspondence with a maximum of fifteen products listed in the official Index of Exhibits. Exhibitors and co-exhibitors can request that their company name is included in the list by product category in correspondence with a maximum of five further products listed in the official Index of Exhibits, at the cost of euro 100 + VAT (the same cost is applied to less than five additional products). Exhibitors that represent other companies have to comply with the same limitations on the listings for products exhibited on behalf of the companies that they represent. Exhibitors and co-exhibitors can request the paid insertion in English only of listings of plant or products that are not included in the official Index of Exhibits, as long as said products are pertinent to the trade sectors covered by GREENPLAST 2025; the rate applied for said extra descriptions, published in the alphabetical list under the company information, is euro 15/word + VAT, with 3 words as minimum, up to a maximum of 30 words. Exhibitors and coexhibitors who have changed company name or who intend to make reference to brands or other commercial names that they utilize, can request paid insertion in the alphabetical list, with a reference to the current company name, at the price of euro 200 + VAT for every additional company name, brand or initials. Exhibitors and co-exhibitors can request paid insertion, in the alphabetical list, of their company logo, at the price of euro 250 + VAT, undertaking to provide the logo in digital format with the characteristics specified in the devoted section of the online form, by 31.1.2025. In such order, it is included also the customization of the official banner of GREENPLAST 2025 with the company logo of the exhibitor. Such customized banner is made available to the exhibitor within 28.2.2025, for the promotion of the exhibitor's participation through web channels and e-mails. Exhibitors and co-exhibitors accept all responsibility as regards orders for the insertion of company or product information that is not pertinent to their business; therefore in no case can PROMAPLAST srl be held responsible for such erroneous insertions.

18 Exhibitor-cards, and cards for mantling-dismantling

PROMAPLAST srl supplies exhibitor-cards, for employees and representatives of exhibiting companies, for the period of mantling, the show itself, and dismantling, according to



stand surface area, up to a maximum of 30 cards:

- \Box for stands up to 16 sqm: 5 cards
- \Box from 17 to 48 sqm: 7 cards
- \Box from 49 to 112 sqm: 12 cards
- \Box over 112 sqm: 15 cards.

Exhibitors hosting represented companies in their stand are entitled to one extra card for every represented company enrolled at GREENPLAST 2025 by means of the respective online form. A co-exhibitor is entitled to one card. Supplementary cards are subject to payment, and can be requested by means of the documents listed in article 19 below. In order to gain access to the Fairgrounds and to pass the security checks, the name of the card-owner and the exhibiting company name must be added to all the cards, to be requested after the official stand notification, through the online Exhibitor portal by FIERA MILANO spa, Exhibitor Pass section (TTE). The exhibitor-cards provide access to the Fairgrounds in the periods of mantling and dismantling (see articles 21 and 22), and during the period of the show itself (see opening hours in article 2). For access to the Fairgrounds during mantling and dismantling, and in particular for suppliers and/or for contracting companies working on behalf of the exhibitor, other cards are supplied according to requirements. These are specific "mantling-dismantling cards" and they can be used only for those periods (and not for the show period itself). After the official stand notification, through the online Exhibitor portal by FIERA MILANO spa, "Accreditation of installer / Vehicle details" section, the devoted internet area for pre-registering people, trucks and car that need access during mantling and dismantling is made available. In said internet area, the general plan of the Fairgrounds can be also consulted, including access Gates and "Rules about setting up and breaking down". After the confirmation via e-mail is sent, both the exhibitor's cards and mantling-dismantling cards have to be printed at the recipients' care and presented at the Gates of the Fairgrounds of FIERA MILANO spa where they will be read through devoted scanners.

19 Exhibitor portal, mandatory and optional online forms After the official stand notification, the exhibitor receives access via e-mail (fieralD) to the Exhibitor portal by FIERA MI-LANO spa, including the technical plan of the assigned stand, the description of the utilities supply, mandatory online forms for safety reasons and optional online forms, in the Purchase in E-Service section, for additional and technical services that might be ordered to FIERA MILANO spa, should these be required. The Exhibitor portal specifies, in the Manage Documents section, which forms must absolutely be compiled by the exhibitor for technical or safety reasons, and returned to FIERA MILANO spa. If the exhibitor does not comply with these instructions and does not return the mandatory forms within the specified deadlines, FIERA MILANO spa, in cooperation with PROMAPLAST srl, reserves the right to block access to the Fairgrounds. The mandatory forms or form sections do not involve any extra costs for exhibitors, except in the case of any supplementary requests that they may decide to make when compiling the forms. The online portal also provides a summary of the orders made by each exhibitor for **GREENPLAST 2025**, and instructions for online personal accreditation for the "exhibitor-cards" and the "mantling-dismantling cards" as described in article 18 above.

20 Stand fittings over 64 sqm

In order to ensure that **GREENPLAST 2025** provides a satisfactory overall effect, PROMAPLAST srl has defined the stand fitting rules, in accordance with FIERA MILANO spa. **Exhibitors are required to fit up their stands. Each wall has to be refinished as per the rule of the art, including the back-wall**. The standard stand height is 3.00 m. For any structure exceeding this height (for example suspensions, whereas feasible and only with the exception of displayed products), the exhibitor is required to keep perfectly neutral the exceeding part toward the adjacent stand neighbor. Any trade mark or graphics toward the adjacent stand neighbor has to keep at least 3m distance from the same, unless written approval of the stand neighbor is given and notified by the interested exhibitor in due time to FIERA MILANO spa.

PROMAPLAST reserves to right to verify - even through FIERA MILANO - during mantling and, in case of noncompliance with present provisions, may carry appropriate refinishing whereas possible, charging related costs to the interested exhibitor.

Exhibitors are required to comply with the instructions contained in the FIERA MILANO spa Technical Regulations, with the obligation on the part of the exhibitor to notify such provisions also to its own appointed suppliers (stand fitters, forwarders etc.).

Exhibitors must apply for approval of the design from FIERA MILANO spa by uploading the documentation required, in the devoted section Activate Stand Fitter and Upload Stand Fittings' Design in the Exhibitor portal.

21 Mantling: start and end of work

The halls of GREENPLAST 2025 can be accessed for raw space mantling from Tuesday 22 to Monday 26 May 2025, while exhibitors with a pre-fitted stand can access the halls on Monday 26 May 2025, unless otherwise agreed in advance with FIERA MILANO spa (see the "Rules about setting up and breaking down" published by FIERA MILANO spa in the website www.fieramilano.it under GREENPLAST 2025 in the Exhibitors section, Technical Documents and in the website www.greenplast.org, in the "Exhibitors" section). During mantling the halls of GREENPLAST 2025 can be used by exhibitors without any extra charges, at the times detailed in the above-mentioned "Rules". Exhibitors and their authorized suppliers are required to follow the times at which they are allowed to be present in the FIERA MILANO Fairgrounds, Rho, as detailed in the above-mentioned "Rules". Failures to follow these rules, whether during mantling or dismantling (see article 22 below) give rise to penalties as detailed in the FIERA MILANO spa Technical Regulations. Extensions to the times at which mantling and



dismantling work can be performed can be requested from FIERA MILANO spa who, in the case that the request is accepted, provides the exhibitor with an estimate for the respective fee, ready for approval by the exhibitor. Exhibitors with more than 64 sqm, whose stand is not supplied by FIERA MILANO spa, are required to begin mantling work by Saturday 24 May 2025 at the latest, or to provide justification in writing to PROMAPLAST srl within the same deadline, stating that they intend to begin mantling only during the last two days available, Sunday 25 and Monday 26 May 2025. Otherwise, PROMAPLAST reserves the right to utilize the stands left unfurnished to construct linking structures as necessary or to install areas of public utility, in order to safeguard the satisfactory appearance of GREEN-PLAST 2025, with all charges upon the exhibitor. In this case, the respective exhibitor can in no circumstances request the reimbursement of amounts already paid, and is required to complete the payment of any sums that may still be owed to PROMAPLAST.

Exhibitors must inform PROMAPLAST srl and FIERA MILANO spa as to the names of the companies (stand fitting contractors, forwarders, etc.) performing work in the stands that have been assigned to them. The right of retention described in article 24 also applies to goods belonging to said suppliers who, in such cases, are considered as being co-debtors with the exhibitor.

22 Dismantling and storage of abandoned goods

After the show has ended, stands must be removed from 30 May 2025 after 6 p.m. till 7 p.m. (only hand carried goods) and from Saturday 31 May till Monday 2 June 2025, which is the deadline as stated in the "Rules" as described in article 21 above. For extended hours during dismantling days, the same provisions set in preceding article 21 are valid. If a stand has not been disassembled and cleared by the end of dismantling, FIERA MILANO spa cannot accept any responsibility for goods and materials, and for whatever is stored in the stands, and it reserves the right to clear the stand and store the materials, accepting no responsibility in these operations, and at the exhibitor's expense and risk. After two months, goods that have not been reclaimed can be sold by auction, and the sums received, after having deducted expenses and other costs due to FIERA MILANO spa, are credited to the exhibitor. The fact that an exhibitor's materials remain in the Fairgrounds entail the payment of a charge to FIERA MILANO spa for the occupation of Fairgrounds space after the duration of the show itself.

23 Stand attendance – Surveillance and Custody

During the times at which the show is open to the public, as described in article 2 above, and for all days of the show, the exhibitor must guarantee the presence of staff at the stand assigned, and must not begin dismantling operations (including graphics or products removal, packaging of any material etc.). before the time at which the show closes to the public (6 p.m. on Friday 30 May 2025). The exhibitor shall bear the responsibility for any noncompliance and the ensuing complaints from visitors. The general surveillance of the pavilions is carried out by FIERA MILANO, which also provides for the adoption of fire prevention measures. The Technical Regulations of Fiera Milano specify the rules that exhibitors must follow in order to cooperate in fire prevention. The responsibility for the custody and surveillance of the stands and of everything contained and exhibited therein, during the opening hours of the pavilions, both during the Exhibition and during the assembly and dismantling periods, rests solely with the respective exhibitors.

The custody and surveillance of the stands and the goods contained therein shall be the responsibility of the respective exhibitors during the opening hours of the halls, including during the assembly and dismantling periods. Company personnel are therefore advised to be present at the stand punctually at the opening of the halls and to guard the stand until the last moment before closing time in the evening. Valuables that can be easily removed should be locked away in drawers or cupboards every evening.

PROMAPLAST and FIERA MILANO shall not be held responsible for any goods, materials or other items left unattended in the Exhibition Centre.

Parking inside the Exhibition Centre: The Organiser and FIERA MILANO shall not be held responsible for the custody, damage or theft of vehicles parked inside the Exhibition Centre. Only vehicles with a special permit are allowed to park in the car parks and during the opening hours of the FIERA MILANO.

24 Right of retention - Statements of account - Exit Passes

During the days preceding the end of the show, FIERA MI-LANO spa provides a summary of all the invoices issued for supplementary services and utilities, and for any other charges not yet paid. Any claims regarding the list of expenses in this account must be presented to FIERA MILANO spa within the end of the show or they are not accepted anymore. The statement of account is uploaded in the Exhibitor portal and payment of outstanding fees at the exhibitor's charge can be settled directly by the exhibitor's offices through bank transfer or with credit card accessing the Exhibitor portal or by showing the statement of account at the banks' offices in the Fairgrounds. The exit at the end of the exhibition of the exhibits, as well as the fittings and any other material pertaining to the exhibitor, is allowed upon condition that Exit Passes are shown to the surveillance guards at the gates of the Fairgrounds; said passes are enabled for exit upon verification that all contractual obligations assumed by the exhibitor towards FIERA MILANO spa and the organizer are duly fulfilled. After the end of the show, PROMAPLAST srl reserves the right, within the limits of law and current regulations, to prevent the exhibitor from removing goods from the Fairgrounds, and likewise the property of any third party suppliers responsible for the stands and for other work, in the case that the exhibitor fails to comply with the contractual agreements accepted by signature of the application form for



admission to **GREENPLAST 2025** and specified in these Regulations (article 2756 of the Civil Code), including the relations between the exhibitor and FIERA MILANO spa, and the latter company's suppliers. PROMAPLAST srl and FIERA MILANO spa accept no responsibility for any damage to materials during the possible period in which the right of retention is implemented.

25 Health and safety at work

For the entire duration of the event, including setup and dismantling of the stands and all associated activities, every exhibitor is required to comply meticulously with the entire applicable system of rules and regulations, particularly those on occupational safety, health and the physical wellbeing of workers, as well as with employment, pensions and social security law and including waste disposal. During stand setup and dismantling, and for any other associated or linked activity, exhibitors further undertake to comply with and ensure that all contractors working on their behalf comply with FIERA MILANO spa Technical Regulations and all amendments and additions therein, which the exhibitor expressly declares to fully acknowledge, and the provisions contained in article 88, subsection 2-bis and the associated implementational Ministerial Decree issued on 22.7.2014 by the Ministry of Employment and Social Policies and by the Ministry of Health. The Technical Regulations, which may be consulted on FIERA MILANO spa website under GREENPLAST 2025 (www.fieramilano.it, link to the "Exhibitor technical information"), also contain precautionary rules on exhibition safety (fire prevention, electrical installations, environmental protection etc.), excluding specific safety-related rules for activities undertaken by the exhibitor or contracted out by exhibitors to contractors (stand setup/dismantling of the stand and associated activities), for which the exhibitor remains responsible for oversight and compliance. In order to comply with the obligations of the above-mentioned Ministerial Decree issued on 22.7.2014, PROMAPLAST srl offers access to these specific documents, Annexes IV and V of the Ministerial Decree, through its website, while available also in FIERA MILANO spa website. Conduct that fails to comply with the above-mentioned safety regulations, in particular if it impacts general safety in the pavilions and with regard to other parties in attendance, may cause prompt intervention by PROMAPLAST srl and/or FIERA MILANO spa as part of regular or random checks, resulting in the immediate cut-off of utilities supplied to the stall or its immediate closure. Any additional consequence that may arise out of a failure to comply with the abovementioned provisions is the Exhibitor's and its contractors' sole responsibility. FIERA MILANO spa may bar staff working for contractors/freelance workers operating on behalf of the exhibitor from the Fairgrounds if they do not possess an ID badge as envisaged under article 18 subsection 1u, article 21 subsection 1c, and article 26 subsection 8 of Legislative Decree 81/08, and non-EU hirees who, even if they hold an above-mentioned badge, do not have a valid and legible Italian green card or a valid and legible ID card. This charge is passed on to the employer responsible for and the contact person for any barred staff. As the contracting party, the exhibitor who authorized such company to operate on site on its behalf to carry out work is informed of the charge.

Exhibitors shall be responsible for complying with applicable laws and regulations regarding all works implemented and organized under their responsibility and on their behalf, including setup, structures, installations, products exhibited and all other associated activities.

Every exhibitor is required to appoint a "stand safety responsible", also defined "Contact Person of the Exhibitor for the Exhibition Safety" (RSE) who, for safety-related matters, takes on all responsibility for all parties who may be involved in terms of the work carried out on behalf of the exhibitor, for the entire duration of their stay on site. At the exhibitor's discretion, and wholly under its responsibility, the stand safety responsible / Contact Person of the Exhibitor for the Exhibition Safety (RSE) may be a different individual during each of the three previously-mentioned phases (setup, exhibition, dismantling). PROMAPLAST srl and FIERA MILANO spa must be informed of the name of the stand safety responsible / Contact Person of the Exhibitor for the Exhibition Safety (RSE) and his/her phone numbers prior to the start of setup work, in any case prior to the arrival, entrance of workers and materials on the Fairgrounds and beginning of setup operations. The names and contact details of the Contact Persons for the Exhibition Safety of neighboring stands are made available to the exhibitors by FIERA MILANO spa and PROMAPLAST srl. Each exhibitor, through his own Contact Person for the Exhibition Safety, must work jointly with the Contact Person for the Exhibition Safety of the neighboring stand so that, through the exchange of information, it is possible to identify any preventive measures to be applied to eliminate or, where this is not possible, minimize the risks of interference, where present. If there is a failure to convey the name of the stand safety responsible / Contact Person of the Exhibitor for the Exhibition Safety (RSE), this responsibility is retained by the exhibiting company's legal representative. FIERA MILANO spa and PROMAPLAST srl must promptly be informed of any change to the name of the stand safety responsible / Contact Person of the Exhibitor for the Exhibition Safety (RSE). The most relevant obligation for the Customer concerns the DUVRI (unified document for the assessment of interference risks), or the PSC (safety and coordination plan) in the event that, respectively, the rules contained in article 26 of the Italian Legislative Decree 81/08 are applied, or those contained in Title IV of the same decree, relating to work safety at construction sites, according to the provisions of the Italian Interministerial Decree of 22 July 2014. This documentation must be uploaded to the appropriate section of the Fiera Milano e-services platform available to the competent authorities (ATS and the police) and be present at the stand for the entire period of the event (including assembly and dismantling).



Access to the stand by contractors operating on behalf of FIERA MILANO spa for the supply of services can only take place in the presence of the stand safety responsible / Contact Person of the Exhibitor for the Exhibition Safety (RSE) and after having received their approval. Fair surveillance and security staff are exempt from this restriction.

25 bis - Measures to guarantee personal safety in the Fairgrounds of FIERA MILANO spa

FIERA MILANO spa, in observance of the instructions provided by the Public Security Authority, has adopted the infrastructural, organizational and operational measures deemed necessary to guarantee the safety of the individuals present for any reason in the Fairgrounds. Merely by way of example, the following may be provided for, at the sole discretion of FIERA MILANO spa:

- a) particular means of access to and exit from the Fairgrounds (specific entrances/exits or reserved lanes, times, systems for the regulation and control of accesses and flows), which may be differentiated according to user categories;
- b) security checks, which may also be carried out with the aid of fixed or portable equipment or instruments, on people, baggage and personal effects, both upon entry to the Fairgrounds and inside it, and, where necessary, upon exit. These checks will be carried out by FIERA MILANO spa staff or by third parties entrusted by FIERA MILANO spa for the purpose. Without prejudice to notification to Law Enforcement Agencies and any measures that may be adopted thereby, users who refuse to undergo checks will be prevented from entering the Fairgrounds. If said users are already in the trade fair district, they will be removed immediately. Users invited to undergo a check must guarantee maximum collaboration, so that the check can be carried out as effectively and quickly as possible given the nature of the activity. Following said checks, and without prejudice to notification to Law Enforcement Agencies and any measures that may consequently be adopted thereby, FIERA MILANO spa reserves the right, at its sole discretion, to refuse entry to the trade fair district to suspect individuals or objects, and to immediately remove any suspect individuals already inside the trade fair district; suspect objects must be immediately removed from the trade fair district by and under the responsibility of those in possession of them. FIERA MILANO spa is under no obligation to provide services for the safekeeping of suspect objects;
- c) variations or limits to pedestrian and vehicular routes within the Fairgrounds, including the positioning of barriers, Jersey barriers, speed bumps and the like;
- d) forcible removal, at the risk and expense of the owner, of means of transport of work equipment, objects or personal effects deemed suspect or liable to interfere with security checks.

The measures in this paragraph are also applicable to all visitors and guests admitted to **GREENPLAST 2025**.

26 CE safety mark – Patents – Machinery in operation

The machines and products exhibited must be built or manufactured or owned by the exhibiting companies and/or by represented companies, who have enrolled at GREEN-PLAST 2025; said products must comply with CE standards and with the respective safety marks. In addition to CE compliance, if the exhibitor shows reconditioned plants, a notice on the occurred reconditioning operations must be shown. Machinery or products without the CE mark, for example prototypes, can only be exhibited if they are accompanied by notices stating that the machinery or products can be sold only after having received authorization to apply the CE mark. PROMAPLAST srl reserves the right to perform checks on this aspect, without any obligation on its part, being the exhibitor fully liable for any consequence deriving from the exhibits displayed. Machinery or products that do not comply with these conditions can be expelled or removed from the stand, at the exhibitor's expense and risk. Exhibitors cannot present, on their own stands, machinery or products that are in conflict with patents belonging to a third party. Should a third party come into knowledge of a presumed violation of this type, it is possible to consult with the specific office in the Fairgrounds in order to initiate the patent dispute. The party promoting this action must notify the exhibitor held responsible and, for knowledge, also PROMAPLAST srl. However, PROMAPLAST srl cannot take any prohibitory actions with regard to the party apparently responsible for the violation, and a final decision in this regard can be taken only by the authorities entitled to pass judgment in this area. However, an exhibitor who, following notification of a patent dispute, is finally deemed to be responsible for the violation by the respective authorities might be excluded from successive editions of the Exhibition. Machinery is permitted to operate during the opening times of the show, or occasionally during said times, as long as this operation complies with all current safety norms, accident and fire prevention legislation, and within the existing limits of acoustic disturbance allowed into job environments. In any case, PROMAPLAST srl and FIERA MILANO spa are exempted from any and all responsibility for any types and extent of damage caused by the machines displayed. The exhibitor remains the sole responsible for said possible damages.

27 Damage caused by the exhibitor - Waste disposal

The exhibitor is responsible for all damage caused to fittings, plant, equipment and goods on show, and to the structures and plant in the halls of FIERA MILANO spa. The exhibition area assigned to each exhibitor at **GREEN-PLAST 2025** must be returned in the same conditions in which it was consigned to the exhibitor. Any expenses incurred by FIERA MILANO spa in order to repair any changes that the exhibitor may have made, and any damage caused, are payable entirely by the exhibitor. The collection, detention, transportation and the waste recovery must be carried on according of Legislative Decree n.152/ 2006 and further modifications and integrations (s.m.i.). Be11



side the service supplied under FIERA MILANO spa responsibility of the cleaning of the stand floor area in the evening before show days (see article 9), the exhibitor is obliged to remove waste from the Fairgrounds on a daily basis and to the management of it in accordance with current legislation. In accordance with the Technical Regulations, the exhibitor and its representatives are jointly and severally liable for the correct management of the waste produced inside the exhibition area and in the assigned exhibition space. It is forbidden for the exhibitor (or its representatives) to dump any kind of waste inside the exhibition areas, both in the assigned space and in the common areas (aisles, roads, etc.). The exhibitor or its staff can make their own arrangements for removal of waste. Alternatively, the exhibitor may use the services of the official operators - all authorised to handle waste and registered in Italy's national register of environmental operators (Albo Nazionale Gestori Ambientali) - listed at: www.albonazionalegestoriambientali.it/Public/Elenchilscritti

The ban on the dumping of waste and the related obligation to properly manage of the same should be understood as referring to all waste materials and materials resulting from fitting/ dismantling work related to the exhibition (packaging, materials used such as walls, false ceilings, floor coverings, etc.). In case of waste dumping in the pavilions or inside the Venue, FIERA MI-LANO spa will apply a sanction of 5,000 euro (fivethousands/00) without prejudice to compensation for further damage, and reserves the right to remove the responsible personnel from the area and to bring legal proceedings against them.

28 INSURANCE - LIMITATION OF LIABILITY

28.1. "All risks" Policy of the Exhibitors (excluding terrorism and sabotage risks)

The Exhibitor must have an All Risks policy on the whole value of goods, machinery, equipment and fittings taken into and/or used in the FIERA MILANO spa exhibition centre with a waiver of right to claim compensation towards Fondazione Fiera Milano, FIERA MILANO spa, their subsidiary and associated companies, the Organiser and any third party involved in the organisation of the event. In case of subrogation from its own insurer, the Exhibitor guarantees to hold the aforementioned Subjects harmless. FIERA MILANO spa furnishes to Exhibitor, free of charge, an "All Risks" insurance with a limit of Euro 25.000,00, to cover all goods, machinery, fixtures, fittings and equipment brought to and/or used at the Exhibition Centre by Exhibitors. Coverage includes the stipulation of 10% insurance exclusion for each claim in the event of theft, with a minimum of Euro 250,00 and doubling this amounts for the reports submitted after the closing of the exhibition. This policy does not apply in the case of:

- selling to the public with immediate delivery of the exhibited products, during exhibitions where such ac-

tivity is prohibited;

- leaving the booth early;

- delaying, without notice, the collection of materials left in the Exhibition Centre.

In the Exhibitor Portal, in the section Manage Documents - Insurance, you will find information on the "All Risks" insurance cover provided free of charge by Fiera Milano. For further information, please contact Marsh S.p.A. Tel. (+39) 02 48538909 E-mail: fiera.milano@marsh.com

28.2. Third Party Liability Policy

This coverage is automatically provided, free of charge, for all exhibitors by FIERA MILANO spa. This will become an extension of its general policy that has a limit of no less than Euro 100,000,000.00 (one hundred million).

28.3. Limitation of Liability

The Exhibitor agrees to hold harmless FIERA MI-LANO spa and the Organizer from any liability for con- sequential losses, reputational damage, loss of revenues, etc. Also for any direct loss, since each Exhibitor has in custody/care the reserved exhibition spaces and is responsible for the goods contained therein, the Exhibitor agrees to hold harmless FIERA MILANO spa and the Organizer from any liability, for goods/values covered and/or not covered and/or exceeding from the above mentioned Art. 1.

The Exhibitor acknowledge that FIERA MILANO spa shall not provide insurance service/policy, or provide any benefit to the extent that the provision of such services or benefit would violate applicable law or expose Fondazione Fiera Milano, FIERA MILANO spa, their subsidiary and associated companies, to any sanction, prohibition or restriction under ONU Security Council Resolutions or under other trade or economic sanctions, laws or regulations. Therefore the Exhibitor under those restrictions, will not be covered by any insurance policy and release hereby Fondazione Fiera Milano, FIERA MILANO spa, their subsidiary and associated companies, against all liabilities for any harmful event that may be suffered within the Exhibition Centers available / owned / managed by the aforementioned subjects, nor will have any action, claim or request against such Subjects, for the aforementioned events.

29 Food and catering services

Exhibiting companies can apply for FIERA MILANO spa food and catering services in the respective section of the exhibitor platform and/or by contacting ristorazione@fieramilano.it – tel. (+39) 02. 4997.6365/ 7425/7805. Third party catering companies and exhibitors who wish to offer food and drink to their guests of their own accord can purchase passes for access and resupply when submitting the necessary documentation.

The procedure is available on the Manage Documents - Catering section of the Exhibitor Platform and in the FIERA



MILANO spa Technical Regulation. In accepting this General Regulation, exhibitors who provide their own catering separately from the services provided by FIERA MILANO spa declare that they are aware of the provisions of the Italian Prime Ministerial Decree dtd. 17 May 2020 and its amendments and agree to observe its requirements.

30 Complaints

Any complaint must be notified in writing by the exhibitor responsible for the stand to PROMAPLAST srl, which assesses each complaint, identifying responsibilities, in cooperation with FIERA MILANO spa in the respective competence areas, and taking the final and indisputable decisions in the best interest of the Exhibition.

31 Arbitration

Any dispute that should arise regarding the interpretation, implementation and resolution of these General Regulations and the FIERA MILANO spa Technical Regulations is settled exclusively by an arbitration committee consisting of three arbitrators, of which the first two are nominated one by each party, and the third by the first two. In the case that one of the two parties does not nominate its respective arbitrator, and after ten days have passed from receipt of the request to nominate an arbitrator notified by recorded delivery letter, the arbitrator is nominated for the respective party by the President of the Court of Milan. In the case that the two arbitrators cannot reach agreement on the nomination of the third arbitrator, or if the third arbitrator has not been nominated within 30 days from the nomination of the two arbitrators, the President of the Court of Milan proceeds to nominate the third arbitrator on request by the first party to make the request. The arbitrators reach their decision by means of unrestricted and amicable discussion, without the necessity to follow specific procedures, and following the adversary principle of hearing both sides, if necessary reaching a compromise decision; their decision, reached according to the principles of law, is considered as wholly substituting the wishes of the two parties, who accept the decision as if it had been taken by the two parties directly, including the provisions regarding the expenses of the arbitration. The arbitrators must accept their nomination within 10 days from notification, and their decision must be issued within the next 90 days, unless this period is extended by agreement of the two parties concerned.

32 Force Majeure

Should the date and/or times of **GREENPLAST 2025** be altered, the duration of **GREENPLAST 2025** be reduced or increased, or **GREENPLAST 2025** be cancelled or postponed as a result of events and circumstances beyond the control of PROMAPLAST – including but not limited to war (including undeclared war), embargo, riots or disorder, fire, sabotage, natural disasters, measures taken by authorities, epidemics, pandemics, health crises (Force Majeure) – the exhibitor is not entitled to withdraw from, terminate or cancel the contract signed on submission of the application to participate in the fair. When a Force Majeure event occurs, the obligations that the parties are unable to meet for this reason will automatically be suspended, without penalty, for the entire duration of the Force Majeure event itself.

Without prejudice to the right of PROMAPLAST to withhold any sums already paid by the exhibitors – to the extent that this is necessary to cover any actual expenses PROMAPLAST may already have incurred and to meet any obligations they may already have entered into with third parties, and subsequently to divide any remaining funds among the exhibitors in proportion to the individual payments made by the latter – the parties undertake, in line with the principles of good faith and fair practice, to take timely steps to agree their mutual obligations during the time the Force Majeure event persists, as well as to do everything in their power to ensure resumption, within the shortest possible time, of the normal contractual obligations that were suspended due to the occurrence of the Force Majeure event.

In any case, a Force Majeure event shall not entitle the exhibitor to request compensation from PROMAPLAST srl and/or FIERA MILANO spa for any damages suffered.

33 Termination clause expressed

PROMAPLAST srl is entitled to terminate the contract by means of written notification to the exhibitor in the following cases: a) the exhibitor's failure to pay the invoice for the balance of participation fee within the deadline as in article 15 above; b) the exhibitor's declaration of bankruptcy, or his involvement in insolvency proceedings; c) the exhibitor's failure to comply with the procedures detailed in article 25 above.

In the case that the contract be terminated in accordance with this clause, PROMAPLAST srl is exempted from all its contractual obligations, and all the money already paid by the exhibitor is retained as reimbursement for the organizational costs sustained by PROMAPLAST srl. In addition, PROMAPLAST srl is entitled to take each and every form of legal action in order to recover the sums that may still be owed and to compensate any further possible damages.

34 Company data processing - Personal data - EU GDPR 2016/679

All the company and product information supplied by the exhibitor and the co-exhibitor with the application form, and successively after its acceptance, is entered into a digital database by PROMAPLAST srl operated in function of its trade fair and promotional activities, for the purposes applicable in relation to the participants at said trade fairs. Mr Mario Maggiani is the holder of data treatment as regards PROMAPLAST srl.
